• The administrators from all municipalities met (along with Metis Crossing staff) on February 24, 2017. A number of items were discussed: the partnership application for Inter-Action Multiculturalism funding for an event jointly, the Regional Heritage Board. Added to the agenda were a Safety Codes update and a discussion of a regional orientation for new council members on common areas such as MMGA, Roles and Responsibilities and Collaboration.

- Report on Water Week
- The accountants have completed the visit to the office for the financial audit and will present the completed financial statements to Council April 24th, 2017
- On February 21st, public works was instructed to close the water supply to 3 properties due to non-payment of the utility account. One property's water supply was returned to service later in the day when a large partial payment was made. Two properties remain off for non-payment at this time.
- The January/February water billings were mailed on March 13, 2017 with payment due March 30, 2017.
- On March 8th, a follow up call was made to the Village regarding the Minister's letter of November 2, 2016 regarding the preliminary review results. One of the items mentioned in the letter was the availability of advisory services including municipal corporate review. The Village can seek such advisory services in future.
- Smoky Lake County held a session about Emergency Social Services, which was an effort to educate attendees (public) about the need to be ready and trained for an emergency event. This includes the training of volunteers who would be needed. About 25 people attended.
- An Industrial Sink was installed in the Public Works Shop.
- With the announcement of the 2017/18 Provincial Budget, it was identified that we are eligible to receive \$37,882.00 in MSI Operating Funds, \$140,461.00 in MSI Capital Funds, \$17,666.00 in Basic Municipal Transportation Funds and \$50,000.00 from the Gas Tax Fund for a total funding of \$246,009.00.
- Records were shredded on Monday, March 6, 2017.

Doctor Recruitment Meeting, March 10

- Need a motion from council accepting budget presented at last meeting. Extra funds to go to reserve account for future recruitment.
 - Moved to invite representative from Bonnyville to our next meeting.

a) Smoky Lake County Subdivision Proposal

Due to the proximity to Stony Creek which is the water way used by the Village to drain the Sewage Lagoons, the Village has received notification of the proposal and has a right to comment on it.

b) Inter-Action Multiculturalism Funding Program

- Under the direction of the Regional Community Development Committee, the administrators met to discuss a number of items including the Inter-Action Multiculturalism Funding Program opportunity. Metis Crossing Manager and their administrator also attended.
- The project is an event of multicultural experiences at the Metis Crossing called "Rendezvous on the River", an opportunity to learn and experience a convergence and exchange of cultural food, dance, music, and art that stems from the roots of our historical community.
- This event can be held in conjunction with the Junior Voyageurs Camp scheduled the end of August, 2017. A learning component of

the project would possibly involve canoeing and may incorporate a tile art project similar to the Town of Vegreville's with student participation from across the provinces.

- An application to the federal government is being prepared. The maximum amount of funding available is \$200,000.00 with \$50,000.00 partner contributions for a total of \$250,000.00
- Application Deadline is March 24th, 2017.
