	• <u>We have received</u> the 2014/2015 Capital Grants. 2014 – 17,666.00; 2015 MSI Cap - \$176,891.00; and \$815.00 a once only increase to the FCSS program.			
	• The Health Advisory Committee met on March 17 th in Smoky Lake. We made a brief presentation, asking for continued support. A motion was made to forward another communication to Alberta Health asking for a decision and support for our proposal.			
	• We have not heard from Chief Franchuk regarding the detailed information he requires from AHS – we hope that			

the Chief will attend a future meeting and explain the First Responders program in more detail.

- The truck-fill pay system turnover of software and equipment is very close to finalized. The County is asking for a formal agreement identifying the donation of the equipment from the County. Loni is dealing with the software provider.
- The financial audit is being completed. Richard Jean will present the completed 2015 Financial Reports to Council at the April 18, 2016 meeting.
- We have been fine tuning the budget and trying to find ways to keep the taxes in line with the previous years in spite of the reduction in the property assessment.
- The next Joint Municipalities meeting is being hosted by Smoky Lake County. The meeting will be held on Friday, April 29th at 10am, in Warspite.
- Deputy Mayor Barry has been able to get information regarding our share of the Evergreen Regional Waste deficit for 2015. Our share of the costs is 7.17% or \$1,806.00. As well, we are going to be getting an increase of \$10.00 per tonne for tipping fees, increasing to \$85.00 per tonne, effective May 1, 2016.
- Loni has attended the Water Wastewater Conference (AWWOA). A presentation at the conference indicated that there is new technology that will help in the grinding of the materials that get flushed into the sewer system that don't break down, a 17 point grind wheel. This should be considered when finalizing the tender for the upgrade of our sewage lift station.

PUBLIC WORKS REPORT

- The winter was spend servicing and maintaining all of the equipment.
- The radiator for the garbage truck was not able to be recored so a new one has been purchased. It will be installed later in the week.
- The backhoe has been taken to JCB to have the brakes repaired. It too should be back later in the week.
- Kevin and Malcolm have been diligent in keeping the water levels under control in the ditches as the spring that progresses.

MAYOR ROMANKO'S REPORTS Highway 28/63 Water Commission, March 3, 2016

- Draft agreement with St. Paul was presented, only one or two changes needed.
- Telus still gathering information for summary execution in summer.
- Alberta Environment has a new drinking water specialist.
- Several crossing agreements have been applied for by companies.
- The work request from Waskatenau for water analysis was presented, no questions.
- Request for \$84,000 from province to complete Phase III will be applied for once the final accounting is completed.
- Thorhild has provided the missing invoices to the Province.
- Charchun Consulting, Land Agents, are working with Inline and Palamarchuk to resolve the rock problem.
- Summary report for Alberta Environment has been satisfied.
- All deficiencies were taken care of.
- Next meeting April 15, 2016.

DEPUTY MAYOR BARRY REPORTS Evergreen Waste Management, March, 2016

March/16

- Audited annual statement presented and discussed;
- Auditor presented some alternatives for dealing with deficit;
- It was agreed to requisition the deficit to the member municipalities. Our share is 7.17% of county requisition;
- The 2016 budget was presented. It includes raising dry waste to \$55.00 from \$45.00;
- The tipage fee will be raised to \$85.00 /tonne effective May 1, 2016;
- Hours have been reduced and personnel have been eliminated in order to meet the deficit;
- Approved U of A study to deal with leachate using 4 different methods (\$15,000.00);

- Disposal of leachate is the second largest expense after wages, (almost the same);
- Discussed some future possibilities for the Commission;
- Some small haulers have indicated that they might be prepared to make a commitment for waste next year when things settle a little more.

Regional Health Authority Council March 17, 2016

- Earla and I attended the Regional Health Council meeting in Smoky Lake. We reminded them of our situation regarding the lack of x-ray services in Vilna and asked for their continued support and help;
- Smoky Lake new CAO suggested that the council could track how many locals sought medical treatment and where they were treated using postal codes; they were provided a list of Postal Codes that are within the Vilna Health Centre collection area.
- The Provinces recent introduction of a new Rural Transportation study was discussed; there was an indication that Diversified Bus Service may be interested in supplementing a bus system in the region using the busses that they use to transport employees to the North West Redwater Upgrader.
- There is an indication that the economic downturn in the province is resulting in doctors looking at rural Alberta for practice options.
- Cold Lake has recently been connected to the Stollery Hospital through Health Link;
- "Wander Guards" have been installed in both the Radway Continuing Care Centre and Lac La Biche facility;
- Naloxone kits are being made available to assist in the fight against fentanyl overdoses.

Regional Emergency Management Meeting Smoky Lake

- Discussed some aspects of the Regional Plan;
- Talked about the manning of Emergency Operations Centre;

- Began talking about specific volunteers for each community, or a regional list. It was resolved that a regional list of people from across county be prepared for various positions;
- Trevor has to talk to Cory and council about the use of County staff to fill these roles;
- Discussed a possible scenario in which a fire north west of Vilna was heading toward village if
 - I, as Director of Emergency Response am unavailable;
 - Don and Loni have to leave fire line and return to run Village

Emergency Management March 7, 2016

- Some of information was a repeat of previous sessions;
- Went over basics of Disaster Recovery Plan;
- Municipality does not have to declare State of Emergency to access funds;
- Emergency Social Services comes under Human Service Dept. not AEMA;
- Had a report for a Meteorologist:
 - only major events make the news lots of similar events little effect
 - talk about the various types of weather events
 - can provide detailed info if requested gas well leak air currents next x hours/days
- Medical Services described what they have available for deployment.

• The volunteers are well into the organizing the Cowboy Fest and the Annual Fair.

Muni-Corr, Trail and COP Program March 21, 2016

- Funding has been received for the trestle repairs.
- A request has been made to burn 3 piles of wood collected at the west end of the Trail in Vilna; the Fire Department has offered to burn the piles.
- The COPS volunteers have been discussing the possibility of getting involved with Emergency Preparedness, perhaps volunteering to provide security services if required.
