ADMINISTRATION REPORT & PUBLIC WORKS REPORT

- I have not received the payment for the permit mentioned in my previous report. As you know the work has already been done, but without the permit and not to the standard of the permit requirements. The change to public land will likely have to be un-done and we will give the requestor the opportunity to do that himself. Otherwise, we will have to do the work and charge it back.
- The budget is ready for your perusal and approval. It is very very tight this year and we have cut back where we can.
- We are still awaiting word from Alberta Transportation regarding the lift station upgrades. If this funding is approved, we can use our MSI for other much needed projects.
- The Transportation consultation meeting between the Department and region representatives was interesting. I'm not sure they understand the needs of a group of small communities, however. We will have to continue to search out opportunities to have input.
- The Continuing Care session held by the Institute for Continuing Care Education and Research (ICCER) in Lac La Biche was also extremely informative and the input given by members of council, administration, foundations, health care providers etc. seemed to have been well taken. The group is interested in meeting again to discuss our regional needs and issues. A meeting of this kind will have to be funded by the group this time, though.
- The backhoe is repaired. Shipping and repairs were approximately \$5,800.00 total. The equipment has been out working on grass etc. Also the back alleys are being worked on now that the tractor is repaired.

• The first meeting of the Regional Fire and Rescue Committee meeting was held and Frank and I attended. Manuals were provided for each committee member, the CAO and the Fire Chief. Our Chief has been provided his copy.

MAYOR ROMANKO'S REPORTS

• Met with TD Bank to arrange to have the Vilna Housing Development Corporation bank account closed.

DEPUTY MAYOR BARRY REPORTS

Public Transportation Meeting April21/16

- Representatives from across region, from Smoky Lake to the Saskatchewan border and Lac la Biche to Minburn met to discuss the Provinces inquiry into Rural Transportation.
- Discussed various aspects of the transportation problem and the fact that there is none and little in way of private bussing;
- Discussed social health and environmental issues associated with
 - Ability to visit family living elsewhere
 - Ability to go to out of town medical appointments /get tests, X-rays etc.
 - Less pollution less traffic on road
- Privately raised issue of x-ray and lab with AHS person Loni followed up by sending her info package

Alberta Hub April 22/16

- Concerned raised about broadband Internet. Supernet's contract up in 2 years then what?
 - Increased usage due to live streaming etc. putting existing system under great stress
- Stress the need to develop an Assessment Management Plan to become requirement to get Federal Gas Tax rebate next couple of years
- When doing a joint project with another municipality have to know what each wants to get out of it and be clear about it
- Colin Piquette is the Chair of the NDP Rural Caucus
- Roundtable issues 5MLAs, Minister Bilous, and Deputy Minister of Transportation attended
 - Redistribution of seats
 - o Economy
 - \circ Grants-in-lieu
 - o Our X-ray lab machines
 - Criteria for highway renewal
- Any amalgamation of municipalities will be voluntary not forced. It was done in Manitoba and has not been successful.
- Talked with MLA Colin Piquette in private about Health Centre. He indicated that they are still looking into it, but are suggesting we will not be successful because the study done does not indicate sufficient numbers to warrant the equipment. He indicated that he had not yet seen the study, but would report to us at such time.

Evergreen Conference Call April 25/16

- Agree to give Trevita the contract to haul leachate until March 17, 2016;
- The suggestion to hire Harvey F (former CAO St. Paul) to help with part of plan, was tabled;

- The reduction in revenues has caused the Commission to exceed its debt limit, an application to the Minister to increase the limit has been made because income down;
- May 3rd meeting was postponed and postponed further discussions because not all members were represented, and to give staff time to assemble information.

Continuing Care Meeting April 27/16

- Put on by research group whose mandate is to improve continuing care
- Continuing care is not just for seniors but for anyone who needs help ----it is an integrated range of services to support the health and well-being of others
- Good discussion of various issues involved
- Report to come out end of June; it was suggested that we should do something with the findings in the report and not just let it be a study that sits on shelf ------ agree we should meet in fall to discuss the findings (Sept).

Fire Rescue Committee

- Met to discuss proposal made over year ago
- Can see all kinds of problems with this
- Tracking response times --- affect insurance premiums for residents
- Working on some sort of checklist for doctors to use in saying someone can return to duty after hospital visit ------ also working on a policy dealing with this have had 5 claims for fire injuries 4 by same person in relatively short period of time
- Talking about some sort of test/determinant to decide if persons can be used at fire/emergency scene(problem someone shows up and tell him can't be here because not meet criteria
- Set meeting for Sept.

Smoky Lake Evacuation Centre

- The Evacuation Centre has been open for two weeks since the Fort McMurray fire evacuation. To date they have accommodated
 - Approximately 180 evacuees. They are open between 8:00 a.m. and 10:00 p.m.; Supplies are available to provide for basic needs;
 - 2 meals each day are provided for evacuees.

a) 2016 Operating and Capital Budget

Administration presented the 2016 Budget to Council for ratification. The elimination of the Grants-In-Lieu for the Alberta Social Housing properties has caused a reduction in the amount of work that can be accomplished in the fiscal year. The province has reduced the MSI Operating Grant to \$38,862.00 for 2016. It was recommended that the tax rates increase to allow for these reductions as well as providing for cost increases. It is anticipated that the Province will approved the grant that will allow for the upgrade of the sewage lift station, accounting for \$325,000.00 in Capital Costs.
