ADMINISTRATION REPORT

Administration's report was presented to Council including:

- Debbie Hackman began her employment with the Village of Vilna on January 13th; 2020 and is going to be a great asset to the organization and the Village.
- We are in the midst of closing the Year of 2019 and preparing for the Year End Audit scheduled for February.
- Over the Christmas break the RCMP located the Village's stolen truck. The damage was over \$7,000.00 so the insurance company has offered \$4,075.00 to write it off. This has been agreed to and we are looking in earnest for a replacement.
- We had a water break on January 1st, 2020 at the intersection of 51st Street and 51st Avenue. The hydrant had frozen and was replaced. The shut off valve was repaired as well. There will have to be road repairs in the spring.
- The computer software at the Water Treatment Plant has not been functioning properly. Renco Contracting will be looking at it to see if it can be re-written or replaced.
- The sale of the property south of the Village has not been completed yet, but the purchaser is waiting for a warmer day to close the deal.

MAYOR CHAPDELAINE'S REPORTS

Evergreen Regional Waste Management Commission – January 9, 2020

- The Organizational Meeting was held with Steve Upton being elected as Chair and Nathan Taylor being elected as Vice Chair. All other positions remained the same.
- Saddle Lake Cree Nation has signed a 3 month term for residential, construction and demolition waste disposal agreement.
- The total Revenues for 2019 was 122% of budgeted amount -\$1,602,361.09and the Operating Expenditures were \$1,302,637.45, showing a surplus of \$299,723.64 which will be set in reserves for future pits and reclamations.
- Next meeting is scheduled for February 6, 2020.

Mayor Chapdelaine indicated that he will not be available to attend meetings during the day until February a12, 2020, requesting that the appointed alternate attend in his place when required. However, he will be available for evening meetings.

DEPUTY MAYOR ROMANKO'S REPORTS

Elected Officials Emergency Management Training – January 14th, 2020

- It has been recommended that a Regional Emergency Management Board be created, that will oversee any incidents in the County. This will not supersede the individual municipality's ability to declare a state of emergency.
- The Regional Board will be required to have at least one exercise per year and an Annual Meeting.
- The Board will be set up by Bylaw.

Smoky Lake Seniors Foundation - December 18th, 2019

- They held their Organizational Meeting with the Board remaining with Randy Orichowski as Chair and Don Romanko as Vice Chair.
- The new CAO, Loni Leslie, is in place and is reviewing all accounts and policies;
- Bar V Nook occupancy 97/101
- Waskatenau occupancy 11/16
- Vilna Lodge occupancy 27/28
- Vilna Dementia units occupancy 9/12
- The Adopt A Senior program was very well received
- The lights in Vilna Lodge have been repaired.
- Their stolen truck has yet to be recovered, so the insurance company has not made an offer on it yet.
