#### **ADMINISTRATION REPORT**

Administration's report was presented to Council including:

- There seems to be a problem at the Water Treatment Plant regarding the amount of water being distributed to the Village and the amount of water we are distributing. Based on the volumes compared to 2019, we have increased our water consumption by 1,736 cubic meters for the month of January. Last year the January Bill was \$5,755.00 this year it is \$10,228.00. Even taking into account the increase of \$0.142 per cubic meter these is no ex planation. We have had Associated Engineers our, and the County has looked at the issue. We are not losing water anywhere. If it was going down the sewer if would show on that meter. If it wasn't it would be in the ditches somewhere. Public Works borrowed a piece of equipment from the Town of Smoky Lake that works like a stethoscope. It can hear running water. They found nothing. The pumps are not working extra to distribute water. Each morning at about 9:00 a.m. the pump increases. Once the school kids are in their classes the pump goes back to idling. If there was a leak anywhere the pumps would be working harder. We thought about the possibility of the reservoir leaking, but when I spoke to the diving company, they said that if there was water leaking out of the reservoir we'd be seeing it long before now. I spoke to the Engineers again this morning. The only possible answer is the meters aren't calibrated properly.
- Utility Accounts Last week we had 4 accounts that were scheduled for shut off. Three of them make payments, but one didn't. Under the circumstances and the attitude of the property owner, we thought it best to transfer the utilities to the tax account rather than stirring up more issues. A letter was delivered to the property owner to this effect.
- The Tax recovery process is well under way. We have 5 properties that are eligible for tax sale this year. One of them has entered into an agreement to make regular monthly payments for 3 years. One had an agreement but has defaulted. If we can get a new agreement we will do that. The other three will likely be put up for auction. The properties will be brought forward to Council prior to the auction to have you set Fair Market Value on each of them.

- There are 8 property owners whose properties will have tax liens registered against them in March. Hopefully this will be sufficient to scare them into making payments.
- The Auditors will be back the first week of March to complete the 2019 Audit.
- Public Works is staying on top of the snow clearing. The Skid Steer is working very well. The snow sweeper died. It was over 10 years old and had served us well. The cost to repair was going to be between \$3,500.00 and \$4,000.00. We were able to purchase a new Ariens sweeper for \$5,027.00 complete with warranty.
- We have received the money from the Insurance Company for the stolen truck. \$4,075.00. We have been looking for a replacement. The one that was behind the office was looked at but found would cost far too much to fix that it would be worth. So we are looking again. The option of trading the grader for a truck is still on the table. Malcolm has been using his personal truck for work. He has asked \$25.00 per day that he works. This is a very fair price, but not a permanent solution. Dale doesn't own a vehicle, so when Malcolm isn't at work, Dale doesn't have a vehicle.
- We have received a few inquiries from people thinking of buying in Vilna who want to know if we allow back yard chickens. So far, our bylaw does not allow livestock. (Chickens are considered livestock). Some municipalities are putting the option forward on a trial basis.
- Debbie has been attending the pertinent meetings and getting comfortable with the region. The number of meetings seems to be overwhelming, especially for a municipality with little assistance. Waskatenau has resolved to step away from the RCDC at the end of 2020. Discussions should be held about the benefits of the many regional organizations. Although it seems that the Province is pushing most of these.
- Joint Muni is our responsibility to Host on March 30<sup>th</sup>. We have looked at the Seniors' Drop in Centre. We were thinking that we could get one of the restaurants to cater.
