3. DELEGATION:

a. ATCO Electric

Sharla McCulloch and Darryl ______ from ATCO Ltd. made a presentation to Council indicating that a ATCO has a program to change all of the High Pressure Sodium street lights to LED lights. They indicated that although the cost to change the system (the multiplier rate) will be applied to the consumer rate, the difference in the price per fixture will be less, thereby saving the municipality money. It is anticipated that within 3 – 5 years the rates will reduce substantially.

The change in fixtures would not relate to the decorative lights on main street.

If Council approves the proposal, the changes could start by early spring.

Mayor Chapdelaine thanked them for their presentation and indicated that a decision would be made later in the meeting.

5. REPORTS:

a. ADMINISTRATION REPORT

TAX SALES

- The taxes have been paid on Lot 22, Block 3, Plan 1887HW so that property is no longer on the arrears list.
- We have some interest in the hotel. Hopefully, we will see results by year end.

CAPITAL PROJECTS

- The 49th Avenue Water and Sewer main project has been completed for the season. The landscaping and road surfacing will be completed next spring.
- The Main Street Sewer Repair project and the 52nd Avenue Sewer Manhole replacement took approximately 5 days. The grant for the main replacement and manhole replacement was approved through the Alberta Municipal Stimulus Program. We received the funds last week. The project was completely covered by the grant. The sidewalk repair will be part of next year's budget. The weather got too cold for concrete work.
- We should be able to proceed with the water meter replacement program early in the new year. We'll do the ones with inside shut off valves first, and the ones requiring new shut off valves will be done in the spring after the ground thaws, so if necessary, we can safely turn off the cc's.

WATER TREATMENT PLANT RESERVOIR

• We have had trouble keeping the chlorine levels up in the water reservoir. We hired divers to check for problems. They video'd the whole process. There was rust and cement powder on the bottom. We had them clean and video in March as well. I have sent the videos to Associated Engineers to see what they recommend. It appears that the concrete over the section of the reservoir that is under the tennis court is deteriorating. The rebar is showing. The rust is coming from the cast pipes.

TRANSFER STATION

- The Fire department has burned the wood and cardboard pile. Public Works took their equipment out there and cleaned up the area. There is a new recycle bin there where old electrical appliances and electronics can be discarded.
- Lin will be taking the Transfer Station Attendant's course next time one will be offered.

GRANTS

- The Municipal Operating Support Transfer (MOST grant is specific to assisting municipalities who have lost revenues or incurred extra costs during COVID. We have received \$34,365.00. I have one price estimate for the computer hardware and software, I am waiting for another quote. I will be summarizing the expenditures incurred because of COVID, and possibly some expenses that we haven't spent yet.
- Regarding the Amalgamation proposal, to date we have had no formal response from the County, but they are looking into it.

VILNA CENTENNIAL – 2023

• The Vilna School will be celebrating its 100th anniversary in 2021. I have the tax records from 1921. The Village will be 100 years old in 2023. Should we be thinking about a home coming sometime after COVID?

Interim CAO, Wagar explained that a payment to Spectre Systems in the amount of \$634,882.50 was the full cost of the 49th Avenue construction project for which the funds were in the Reserve Account, and a payment to Spectre Systems in the amount of \$59,734.50 was paid to cover the cost of the Main Street Sewer repair and a repair to the service to 5016 - 50 Street and the manhole replacement at the west end of 52nd Avenue. This project was covered by the Municipal Stimulus Grant. There was also a payments made the MPE Engineering for their work on the ACP Storm Drain Study Project in the amount of \$25,834.27. The final exceptional payment was to Aquatech Divers in the amount of \$10,119.38 to determine the reason for the chlorine levels in the water reservoir to be fluctuating.
