# TAX SALES

• As indicated above, the Village has property that has outstanding taxes of \$24,839.99. The majority of the outstanding taxes is for 1 property, that being the old lumber yard with \$22,082.81 owing. It seems that Public Works has been using the property for storage of materials. We would like Council to consider transferring that property into the name of the Village and have it property fenced. We will have to pay off the outstanding taxes.

## CAPITAL PROJECTS

• I haven't had time to review the Grant for the Water Meters. It turns out Waskatenau is looking to upgrade their meter reading software, so we may be able to work with them.

### WATER TREATMENT PLANT RESERVOIR

• All testing levels are normal again.

I've been talking to the Engineers about options for the reservoir. We've talked about draining it and cleaning it and applying a liner or coating. This brings up two questions, firstly, do we need a reservoir of this size or should we be looking at downsizing it somehow, and secondly how do we function for up to a month with the reservoir drained?

The majority of our storage capacity is for fire protection.

# GRANTS

 The ACP (Community Partnership Program) again has funds available for regional projects. We have a study done on our infrastructure including water lines, sewer lines, roads, storm sewers, and asphalt. The storm sewer project and the facilities study are nearly completed.
 I have submitted an application, as the Managing Partner so do a study on

**Regional Municipal Service Delivery Options.** It is hoped that this study will provide some innovative ways of administrating municipalities.

• A third regional ACP grant this year was the installation of our GIS software and inclusion of our assessment data, roads, sidewalks, fire hydrants and valves. There's a lot of work to be done to make it functional. Public Works will be adding service cc valves and other data as it comes up.

### PUBLIC WORKS

- The Christmas lights have come down.
- The staff has been cutting their hours through the winter, unless we get snow.
- The snow has created work for them, but they seem to staying ahead of it.

DOGS

- We seem to be having problems with people not respecting their neighbours, nor the bylaws and appear to be negligent in controlling their dogs.
- This is my goal for 2021. I will find a way to get a handle on the dogs in the Village, without having to hire a dog catcher or animal control officer. I think I'll start with letter writing and emails and phone calls.
- The other problem I'm having is getting people to register their dogs so I don't have any phone numbers to call.
- I might get Public Works to do some door knocking. If a dog answers and I don't have a license for that address I'll start harassing.
- The main purpose for the license is the contact number. I wonder if it would be more effective to make sure that every dog gets registered once.. This would be a life of the dog license.
- The challenge, of course, will be to get the dog registered as soon as it arrives in town.
- I've also been thinking about finding a way to attach the license fee to the utility bill.
- Our Dog Bylaw was written in 2006. It has more words than a dictionary and it's almost impossible to enforce.
- I've put it on the agenda for review.
- Perhaps we can combine the dogs and chickens.
- However, if we can't enforce the dogs, how will be enforce the chickens.
