Outstanding Taxes

- On March 31, 2021 I registered caveats on 12 properties that have taxes more than one year in arrears. I received partial payment on one, and I hope the notification of the arrears caveat will scare some of them into paying.
- I was able to get a tax payment agreement involving 3 other properties;
- I got confirmation of payment on 3 properties;
- We had previous agreements on 3 properties;
- We currently have 1 property that was offered for tax recovery but wasn't sold and is still in the owner's name and 2 that have been transferred to the Village title.
- One is the old lumber yard where Public Works is storing materials. We should take title to it, but if we do that we have to pay for it. Currently there are \$22,000.00 worth of taxes outstanding on it.
- There is one property that didn't sell at tax sale last year. Outstanding Taxes are about \$6,300.00. It needs cleaning up before it will sell. Has an old foundation in the back. I will transfer title to the Village as tax recovery property. It doesn't make sense to add taxes to it only to have to write them off later.

2020 Audit

• The 2020 Audit is almost complete. The auditors will be at your April 15th Meeting to present it to you.

Public Works

- The owner of the highway service station building is concerned that the roadway to his property (49th Street) is very narrow and would like it widened. The road was kept narrow because the overhead power line hangs very now there and could easily be pulled down with a high truck. We would have to get ATCO to move their pole before we could do anything with the road.
- With the frost coming out they want to get the paving and boulevards done on 49th avenue and also repair the street and sidewalk in front of the Outreach School.
- They are currently repairing potholes
- Culverts have been ordered to repair crushed and damaged ones and hopefully deter any future flooding.

Business Licenses

• As per your directive at the last meeting;, I am working on preparing the Business Licenses and letters for the businesses indicating that Council will be forgiving the license fees for 2021.

Water Plant Reservoir

• No grants yet.

2021 Construction Projects

- Water meter replacements
- The initial project for 2021 will be the completion of 49th avenue, including the ditch and boulevard repairs and the surfacing.
- The Infrastructure Study indicates that we will have more water and sewer mains to look and,
- Based on the frustrations with getting the water valves shut off, this is a priority as well.
- 1st calls have been done and the contractor should be here by Thursday to begin these repairs.

Regional administrators Meeting April 6, 2020

- Three topics were discussed.
- 1. Ukrainian Twinning Committee Parameters and bylaw
- 2. Regional Heritage Board Update & bylaw.
- 3. Funding for the Intermunicipal Collaboration Framework was left over, we discussed options for spending the funds that still fall under the parameters of the grant.

MAYOR CHAPDELAINE'S REPORTS

Doctor Retention & Recruitment Meeting – April 8, 2021

- The Committee met to discuss the Alberta Health Services proposal to reduce the number of lab hours at the Vilna Health Clinic. There is a concern that if the lab hours are cut, the necessity to travel to Smoky Lake for tests could implicate the use of the Vilna Pharmacy.
- The Board is compiling letters to be forwarded to Alberta Precisions Labs; Alberta Health Services; David Hanson, MAL Bonnyville-Cold Lake; Glenn van Dijken, MLA Barrhead-Morinville-Westlock; Shannon Stubbs, MP Lakeland; Saddle Lake Chief; Whitefish (Goodfish) Lake Chief; and the three doctors that practice in Vilna. Each of the member municipalities and the reserves along with the doctors will be forwarding letters on behalf of the Vilna Medical Clinic.
- Upon speaking to Alberta Precision Labs Services, they acknowledged that they will hold off reducing the Lab hours in Vilna until all documentation is received and can be reviewed.

Highway 28/63 Water Commission – March 22nd, 2021

- The 2020 Financial Audit was presented to the Board,
 The year closed with a \$25,000.00 deficit.
- Manager's Report
 - Our MLA has been notified regarding the non-payment of the balance of the grant for Whitefish Lake;
 - There is still no resolution from Whitefish Lake regarding the signed agreement, COVID has resulted in less meetings;
 - A report is being prepared for the possible expansion of the water line from Newbrook to Waskatenau. The expansion need is cited as an increase in

the use of truck-fills as well as the potential for adding Saddle Lake Reserve and Kikino Settlement to the system.

- Associated Engineers
 - o gave an update on warrantees,
 - Reviewing upgrades of lone from Newbrook to Waskatenau for future connections.
 - o Goodfish Lake reservoir is ready except for outside work,
 - There has been no correspondence from the Province or MLA;
- Bylaws need to be updated by September, 2021,
- It is proposed that a template letter be written to NE MuniCorr regarding their proposal to charge fees, indicating that the charges would be a breach of trust.

Administration reported that the Penalty Section of the Bylaw had been sent to Municipal Affairs for consideration and recommendation. Amendments are being make.

Council reviewed the proposed updated NE MuniCorr Bylaw and agreed that the proposed bylaw is acceptable except for Clause #11 which restricts utility companies from accessing the corridor to service their utilities.
