## UTILITIES

• We have about a dozen accounts that are more than 2 months in arrears, but they have been notified that it not paid by December 31, 2021 the balances will be transferred to the taxes. We're more assured of getting our payments that way than shutting off water services.

## **PUBLIC WORKS**

• On September 16<sup>th</sup> the garbage truck turned a corner too sharply in the alley behind the shop. It hit the power pole and took out much of the telephone services in the area. No one was hurt. We have submitted an insurance claim to cover all costs resulting from the incident.

• The 4-way Stop Signs seem to be slowing down the traffic. There are a few people in the area that don't like them, but they are probably the ones who were speeding.

• They are taking advantage of the warmer weather and have been handing Christmas lights.

### **CAPITAL PROJECTS:**

## WATER METER REPLACEMENT PROJECT

• The meter replacement project is scheduled to begin on November 15<sup>th</sup>. The meters are here and the contractor is scheduled to start installations on the 15<sup>th</sup>. I have recommended that they do the difficult one first, i.e. mobile homes.

## WATER RESERVOIR

Public Works has been tasked with submitting at least 2 times the number of tests that we had been doing as well, they will be flushing the hydrants more regularly, even when it gets colder. This will insure that the water stays fresh.

• The project is progressing, waiting for interim funding as well as project funding.

### **CENTENIAL PARK**

The title transfer from Smoky Lake County to the Village of Vilna went through on November 3<sup>rd</sup>. The committee can start planning.

### **GRANT APPLICATIONS**

• The Grant Agreement for the Regional Services Study is still waiting for the Ministers signature. We are scheduled to meet with the contractor 13'Ways on November 24<sup>th</sup>.

• An application is being prepared to have a study done on the High Speed Internet in the region.
