TAX SALE

- The Tax Recovery Sale by closed tender was a success. We sold 6 of the 8 properties. The 2 properties that were left are the 2 vacant lots across from Side Street. One is serviced and one isn't.
- Notices were sent out to everyone who has an outstanding balance on their taxes. I have estimated that we should receive about 24,000.00 in current taxes prior to year-end. It this calculation is correct we should have collected 90.2% of the current taxes, which puts us back in the good books with Municipal Affairs.

PUBLIC WORKS

- We have changed the water valve in the fire hall from a 3 inch valve to a 2 inch valve. This will extend the time it takes for them to fill a truck from 5 minutes to about 7 minutes, but it will reduce the potential of causing a water break in front of the fire hall.
- We have about 10 driveways that Public Works is clearing this year.
- Dale is taking the Water Wastewater course. We have been dependent on the County Operators and have been operating under Dave Franchuk's license, but Dave's license expires at the end of December. So, rather than use another County License, Dale has offered to take the course.
- For all those people who complain that we don't clean the streets well enough, there's a reason. The compacted snow creates in insulated barrier and reduces the chances of having a frozen water line. The way the temperatures are dipping this winter, we're all sitting with crossed fingers.

WATER RESERVOIR

• The chorine levels seem to be stable.

UNSTOPPABLE CONVERSATIONS

- We've had 2 sessions with Vik Maraj including the staff from Bashaw. These sessions included the Town of Stettler as well as our regional partners. I think that having more communities created a more diverse range of ideas.
