2. DELEGATION

Cpl. Roxanne Genereaux, Acting Commander of the Smoky Lake RCMP Detachment met with Council to present the 3rd quarter statistical report and discuss concerns and issues in the Village.

She reported that Crimes Against Persons dropped, Property Crimes increased and so did Other Criminal Code Crimes.

A general discussion was held regarding concerns and issues in the Village.

Cpl. Genereaux indicated that she would like to have some informal coffeeshop type conversations with the community.

The RCMP has launched a mobile app. It can be accessed through the Apple App Store or the Google Play Store. The platform provides the public access to Crime Reporting, Access to Crime Statistics, News, Mental Health Support and other information that allows the public to access the RCMP more easily.

James MacDonald, Executive Director, Northern Lights Library System met with Council to share the 2021 Value Statement highlighting the benefits of belonging to the NLLS. Not only does our Library lend out books, but it provides programs and support to help people learn.

He described the breakdown of the financial contributions from the municipalities, including purchasing books, providing technical support to the libraries, providing the services of a Librarian, as well as on-line programming.

 - They are experiencing a serious problem with the flagrant disposal of "sharps".

• RCMP Webinars

- Information Sessions and discussions around the potential of the Province of Alberta setting up a Provincial Policing System and cancelling the Federal Contract for RCMP services.
- Based on the discussion it seems that 99% of the municipalities are not in favor of switching. There is a possible referendum coming later in the year.

• Agricultural Society

- The AGM saw a minor change in Executive. They have amended their bylaw to reduce the Board from 12 member to 9.
- The arena roof and chillers have been repaired, but there is an issue with the electrical services which were installed with aluminum wiring. This is prohibiting them getting property insurance. Currently they have liability insurance only. The arena is not operating. The curling rink is operating.
- The majority of the meeting covered the 2022 Boom Town Days and the Centennial Homecoming Celebration, the theme being "VILNA CELEBRATES".

• Vilna and District Municipal Library

- The AGM showed new members and new Board Members
- The Library is introducing a series of new programs to attract and retain members of all ages and groups
- They provide a once-a-week library service to Good Fish Lake
- The Library through the federally sponsored AXIA system, has free wi-fi, available by using your library card. It seems there is also free wi-fi at the school and the outreach school through this program.

• Electric Vehicle Charging Program

• There is a grant program being looked at that could put EV chargers into each of our communities. The restrictions are related to the necessity to have the chargers on municipal properties and the availability of phase 3 power.

• A discussion was held around the Level of the charges that will be covered by this grant.

b. Deputy Mayor Thompson

- Smoky Lake Foundation -
 - The Foundation is running smoothly, not experiencing any issues that require Board Direction.
 - $\circ~$ The CAO evaluation is scheduled for February 10th.
- Ukrainian Twinning Committee -
 - The structuring of the Committee is complete.
 - The Mayor of Kosiv attended the meeting (Virtually)
 - He commented on the political unrest in the Country indicating that the activity is happening on the east side of the Country and Kosiv is in the southwest central part of the Country. He explained that they don't feel much of the pressure.
 - A confirmation of their request for medical and fire protection equipment and gear was made.
 - An ambulance and a sea-can of fire equipment and gear is being processed for shipping.

c. Councillor Miranda

- RCDC
 - The CEDO is working with Vilna on a Business Support initiative, a Mainstreet Revitalization program, and promotion of our assets.
 - A presentation from and a discussion with Doug Griffiths and Stuart Fullarton from 13 Ways Ltd. presented potential for having our shared services study incorporating community enhancement and viability in the region. They have asked for a face to face meeting with all of the Councils and administrations in the near future. A potential date is February 23rd at 5:30 in Smoky Lake. The venue has yet to be determined.
 - Tourism is a high focus on the region
 - A discussion was held around affordable housing. Housing needs to be considered at the same time as business attraction is considered. Housing will vary depending on the type of businesses being attracted.

CENTENIAL PARK

- Not this grant either. There are all kinds of grant programs, but not very much money.
- We have a meeting scheduled for Monday, Feb. 14th to get people organized.

GRANT PROJECTS

• The Regional Services Study project is well underway. Each of the municipalities have had an opportunity to meet with the consultants. The consultants met with all the CAO's a couple weeks ago, and they made a presentation to RCDC on Tuesday. They are hoping to MEET with all the elected officials and administration around the 24th of February.
