WATER METER REPLACEMENT PROGRAM

Kick-Off date for the Water Meter Replacement Program is scheduled for November 15th, 2021. Shortly, you will receive a letter from NEPTUNE TECHNOLOGY GROUP. You will be asked to book an appointment to have your meter changed. Reply as soon as possible.

They will be identifying themselves and you will receive confirmation from the Village. Be assured, they will be following all COVID-19 Protocols. They will each have at least two (2) COVID vaccine injections.

This should be the last time you will have to read your water meter for us.

BACK ALLEYS

I'm sure you've noticed the surfaces in the back alleys. We re-used the asphalt that was taken off 49th Ave West, ground it up and spread it in the alleys. It's a bit course, and perhaps a bit rough, but we're confident that it will break down and compact into a solid surface making the alleys accessible all year.





TREATED WATER RESERVOIR

Over the next few months you will notice some activity around the water treatment plant. The plant was built approximately 40

years ago, with upgrades to the treatment system when new technologies came out, and upgrades to the pumps within the last 5 years. In 2014 we closed our well and connected to the regional water system. Prior to the switch over the reservoir was vacuumed and videoed. At the time it was identified that the concrete ceiling of the reservoir was showing signs of deteriorating. We have been monitoring and vacuuming it annually since then. This year it started to show more deterioration. It has come time to repair the damage and make plans to replace the reservoir.

The water reservoir is an underground concrete storage vessel that holds the treated water. Our water is drawn off the regional line approximately every 2nd day and stored in this vessel. It is large enough to hold sufficient water for domestic use as well as to provide fire protection to the community.

We've had the facility inspected by Alberta Environment (*who makes the regulations for safe drinking water*), and Alberta Health Services (*who monitor the water tests*). Both departments agree that the water continues to be safe. Our contracted engineers will be designing the necessary repairs. Until the repairs are completed we will be doubling the water quality testing to 4 laboratory tests per week as well as the daily testing.

Of course, the major challenge is getting grant funds to cover the costs. Unfortunately, we are not the only municipality facing very similar issues. With assistance from the County, the Water Commission, Alberta Environment and Alberta Health we should be able to get funding in a timely manner.

In the meantime, be assured that the water the Village is providing is well within the guidelines set out by Alberta Environment and Alberta Health. You will be notified immediately if anything changes.

• 40 km/hour.

<u>U-TURNS</u>

Another question that has been raised recently is: *Is it legal to make a U-turn at an intersection in Alberta?*

- A U-turn is done by turning your vehicle around at an intersection to go in the opposite direction by using oncoming lanes.
- When U-turns are not permitted:
 - Do not do a U-turn unless you can do it safely.
- U-turns are not permitted:
 - at an intersection controlled by a traffic control signal (*traffic lights*) unless permitted by a traffic control device, or
 - \circ where a sign prohibits U-turns
 - In urban areas, U-turns are not permitted:
 - $\circ \quad \text{on a roadway between intersections} \\$
 - o at an alley intersection
 - at an intersection where one or more of the roadways is an access to a public or private parking lot which the public can access.

Bottom line – yes you can legally make U-TURNS at the 4-way stop intersections, as long as you can do it safely. Watch for other vehicles and pedestrians.
