**2023** started out at minus 35 degrees, moving into a hot dry spring full of forest and grass fires. Summer and fall were more normal than anticipated, but who could have guessed that we would still not have snow and the temperatures get above zero during the day?

## We're facing a drought

We received a letter from Alberta Environment & Protected Areas. They have a scale in its emergency water management plan ranging from #1 being minor drought and #5 being Province wide emergency. Currently, they have indicated that we are in stage #4, indicating that unless we get snow and spring rains we will be faced with a Province Wide Emergency and will be forced to restrict use of water. A Drought Command Team will be set up and all usage of water in each municipality will be monitored and controlled. The Province is asking all water users (you and me) to start planning now to use less water. Intermunicipal Collaboration Framework is a required format for municipalities with common boundaries to identify the services that benefit residents in more than one of the municipalities; identify which municipality is responsible for providing these services and outline how services will be delivered and funded.

We are currently discussing the structure of a **Regional Fire Service**. It has been determined that we do not have sufficient trained volunteer firefighters to provide a continuous service and are therefore looking at the possibility of hiring paid fire fighters through the busiest fire season.

Early in the year the possibility of contracting the **County Bylaw Enforcement Officer** was



discussed, and is still being discussed. This topic falls under the Intermunicipal Collaboration Framework. It was that the Regional Fire Service agreement holds priority over Regional Bylaw

Services, so the Contract with Smoky Lake County to use their Bylaw Officer is delayed.

## **Community Standards Bylaws**



Council reviewed the unsightly Premises sections, the traffic and parking sections in an attempt to ease the

enforcement and encourage residents and businesses to put pride into their properties and enhance the attractiveness of the Village.

## Pet Ownership Bylaw

Pet owners are reminded that the loveable creatures are your responsibility. Your neighbours might not



love them as much as you and would prefer that you keep your dogs and cats on your own property.

A test program was initiated to determine if hens or bees would fit into our community. Unfortunately, the regulations required by the Province made the enforcement of these options difficult. Council has resolved to remove the keeping of bees or hens from the pet bylaw.
