TAX SALE

- The last property sold at the Closed Tender Sale has been paid.
- Now we start on the ones outstanding that will be set up for auction in 2023.

PUBLIC WORKS

- Dale has taken the Water and Wastewater course, so we will no longer be dependent on the County for our testing and reporting.
- Winter in Alberta means snow, wind, rain which equates to questionable streets. We had all the piles of snow moved 2 weeks ago, but the piles are building up again.
- Where we had "sand-snow" last month, we have slippery streets this month.
- The three frigid temperature water breaks in December cost us \$63,111.30.
- Malcolm and Dale are reducing their hours when there is no snow to clear. This will help a bit to keep the budget down.

WATER RESERVOIR

• The chorine levels seem to be stable. Alberta Environment has indicated that we can reduce the special testing to bi-monthly or even tri-monthly.

BANK FRAUD

- \bullet The hacking into our bank account on January $18^{\rm th}$ has caused increased security and compounded stress.

- The Bank was able to recover \$20,000.00 of the \$25,000.00 that was stolen.
- Contacted the insurance company, but it seems that the deductible is the amount unrecovered.

RCDC

- With Michelle Wright resigning, it's going to be a challenge moving forward with the Vilna's revitalization. She has offered to continue to work with us, but we need to narrow down the concepts and ideas in order to get on a specific path.
- Thomas Barr from Atlas Projects hosted a webinar as an introduction of his scope of practice. He aims to help communities become independent and resilient. He has offered to work with Vilna to develop a plan that has a sound economic backbone that shows anything is possible as long as we are willing to re-think and re-define the way things have been done into the way things now need to be done.
