DELEGATIONS:

James McDonald from Northern Lights Library System provided 2023 Statistics for the Regional Library System as well as the Vilna Library. Vilna Library circulated 1,815 printed books, 462 e-books and 51 e-audio books in 2023.

In 2024 they contracted the drivers for the distribution trucks creating a manpower and financial savings.

In 2025 NLLS is proposing providing wireless printing in the libraries. They are also planning to create an interface for the catalogues throughout the system.

The budget proposal will see an increase in the Municipal Levy by 1.5% for 3 years.

Mayor Kunyk thanked Mr. McDonald for his presentation and acknowledged the assistance that NLLS provided to Vilna and the Vilna Library .

ADMINISTRATION

• As the date of the Auction Sale gets closer there are less properties to sell. 3 of the properties have payment agreements, 1 has been paid in full, 3 have a pending sale and 1 has a request to be deferred (due to a foreclosure in progress).

PUBLIC WORKS

- The crew is replacing some of the wood sidewalk pieces.
- Bonnie Lake is being winterized. The dock is out, but we still have people camping.

WATER RESERVOIR

 The Project Manager from Alpha came to Vilna to do a site visit to see it in person to determine best steps, such as building placement and placement of the construction site structures.

- Design package will be 75% completed by October 31, 2024, 90% by November 29th.
 Invitations for Construction Tender should be ready by December 24th, 2024.
- AE will be sending us bi-weekly updates.

SEWAGE LAGOON

• Public Works is planning on releasing the lagoon in November. Notifications to the adjacent property owners will be sent out prior to the release.

COMMUNITY STANDARDS

- At the last Municipal Administrators meeting we learned that the County Bylaw Enforcement Officer recently resigned. There is potential for contracting Bylaw Enforcement and Animal Control to the urban municipalities. County CAO Kevin Lucas indicated he would speak to County Council. Each of the urban municipalities are willing to enter into an agreement with the County.
- Building Addresses –another 22 notices went out reminding people to install house numbers. By the end of October the Village will begin applying fines. We can't access their property to install numbers but we will keep adding the fines to their taxes until it gets done.
