- Peace Officer: An independent Peace Officer operating out of Bonnyville may be willing to contract to regional municipalities.
- FCSS: A proposal to regionalize the FCSS programs will be discussed.

# c. Administration Report to Council July 30, 2025

### **WATER RESERVOIR**

Admin has submitted a grant application with ABMunis for the solar panel portion of the building.

### **PUBLIC WORKS**

- Hydrants were flushed this week.
- > The campground is being maintained by Village PW staff.
- > Repairing sidewalks and patching asphalt is ongoing all summer.
- > 8 new picnic tables were placed in Bonnie Lake Campground. We need another 8 for next year.

#### **ADMINISTRATION**

- ➤ The tax sale will occur on September 17, 2025
- > The Occupational Health and Safety Officer issued orders for documents. That was done and we received a "well done" pass.
- > Catalis is planning updates to our Regional GIS platform
- > The Firehall Lease Agreement was drafted and to ICC for the meeting July 29.
- ➤ "Freedom of Information and Protection of Privacy" Act has been replaced with 2 separate laws the Protection of Privacy Act and Access to Information Act.
- > We continue to work with the RCMP about vehicle drivers in the Village. Where available, video is sent.
- We will have to add a speed bump (or two) to 49<sup>th</sup> Avenue West. We have had a disturbing number of high speed complaints.

#### 6. BUSINESS

### a. Tree Management

Trees on the boulevards and on municipally owned property are in serious need of pruning or removal. This item was not included in the 2025 budget and so it is being recommended that Council approve this as an unbudgeted item.

**RES: 090-025 Moved by Mayor Kunyk** that the Council of the Village of Vilna approve an unbudgeted expenditure of \$4,025.00 for the removal of trees that require removal due to health, location and potential to cause damage to property. **CARRIED** 

# b. Street Sweeper

In 2008 the municipalities of the region collaborated to purchase a street sweeper (\$165,000.00) using an MSI grant. Over the years the sweeper has required repairs and parts, but is becoming difficult to repair and parts hard to source.

The CAO's will be meeting to discuss their recommendations to ICC regarding the potential of replacing the current sweeper or other options.

#### c. Rodeo

As part of the Vilna Ag. Society's Boomtown Days, the Roughstock Rodeo is coming to Vilna August 15, 2025. As an event in the Village, it will pull people, and therefore revenue for our businesses to the Village. The Rodeo organizer has requested a contribution from the Village to the rodeo in the amount of \$200.00. Revenue generation from the rodeo is going to the Vilna Ag Society and not the rodeo organizer.

**Moved by Mayor Kunyk** that the Village of Vilna recognizes the economic advantage of events for businesses within Village and approves the contribution of \$200.00 to the Roughstock Rodeo event to be held on August 15<sup>th</sup>, 2025 and the Vilna arena. **CARRIED** 

# d. RCMP Community Development Fund

**Moved by Deputy Mayor Thompson** That the Village of Vilna recognize the importance of the RCMP to our community and approve the contribution of \$100.00 to the RCMP Community Development Fund or approximately \$100.00 worth of candy to be distributed by the RCMP during the 2025 Boomtown Parade. **CARRIED** 

# e. Fire Hall Lease Agreement

As part of the soon to be agreed upon Smoky Lake County Regional Fire and Rescue Service, the County has resolved to lease each of the firehalls from each of the 3 participating Urban Municipalities.

**Moved by Mayor Kunyk** that the Council of the Village of Vilna confirm the terms of the proposed Fire Hall Lease Agreement with Smoky Lake County including a clause that will give the Vilna and District Volunteer Firefighters Association use of one service bay, one storage unit and the mezzanine floor to use for their Community and Social activities, conditional upon acceptance by the Inter-Municipal Collaboration Committee and Smoky Lake County.

#### f. Purchase of a Shelter for the John Deere Tractor

The John Deere tractor has been housed in the Arena due to lack of storage space within the PW Shop. The PW Foreman requested an outdoor shelter for it as they have been asked to remove the tractor from the Arena as quickly as possible (by the end of this week as per Vilna Ag Society). They plan to begin using the Arena more often, primarily for the rodeo coming August 15, 2025.

This is an unbudgeted item. A new shelter of sufficient size is estimated to cost \$730.00.

The CAO purchased this same sized shelter a few years ago but has not been able to use it. It has been offered to the Village for the cost of \$400.00. Regardless of budget, this requires approval of Council if purchasing from the CAO.
